## 4100ES Fire Indicator Panel Operator's Guide

Fire detectors in the building are grouped into zones (searchable areas).

Zones can be Isolated by pressing the zone's isolate pushbutton on the panel – this prevents an alarm from activating the panel outputs.

When a non-isolated detector detects an alarm, the fire panel displays the alarm information, calls the fire brigade, activates the Warning or Evacuation System (EWS), and initiates any other programmed functions.

The fire panel display consists of two sections – the operator interface (upper section) and the Zone Isolate pushbutton switches & indicators (lower section).

The operator interface indicates common Alarm, Fault & Isolation Status on LEDs, and point (detector) status on the LCD.

When an Alarm, Fault or Isolation occurs, the buzzer will operate until the corresponding

acknowledge (Ack) key is pressed.

**Silence the External Bell or Strobe:** Press the <EXT BELL ISOLATE> key.


**Silence the Evacuation System:** Press the <WARN SYS ISOLATE> key. This will turn off warning sounders powered by the Fire Panel.

**Isolate a Zone:** Press the appropriate Zone Isolate pushbutton and the Isolated LED for that zone will turn on.

**Acknowledge an Isolation:** Press the <ISOLATE ACK> key.

**Acknowledge an Alarm:** Press the <FIRE ALARM ACK> key.

**Acknowledge a Fault:** Press the <FAULT ACK> key.



The panel is reset by pressing <SYSTEM RESET>. If an alarm won't reset, the point may still be activated. Press <FIRE ALARM ACK> when the point alarm is displayed, then press <DISABLE>, <ENTER>. Press <FAULT ACK> (to acknowledge the fault caused by disabling a point), then press <SYSTEM RESET> again. The disabled detector must be re-enabled when the condition is cleared.

# **Chapter 1 Overview**

## **Typical Panel Layout**

#### Overview




Figure 1-1. Zone detail

The 4100ES is supplied with an InfoAlarm graphic Operator Interface plus one or more Expansion Bays in a suitably sized cabinet. Refer to Figure 1-1.

The Zone Isolate modules are fitted into the Expansion bays from left to right. The first zone is at the top of the leftmost module.

Depending on the size of the system and other functions required, Zone Isolate modules may be fitted to the entire bay and additional Expansion Bays may have Zone Isolate modules fitted. Small systems have only one Expansion Bay, and any required other modules are installed to the right of the Zone Isolate modules.

## **Basic System Description**

#### Overview

The Simplex 4100ES Fire Indicator Panel (FIP) has three general functions.

- It monitors fire alarm *initiating points* (smoke detectors, heat detectors, etc.).
- It activates fire alarm *notification devices* (voice evacuation, bells, strobe lights, brigade call) when an initiating point activates.
- It monitors and controls ancillary building equipment (fan controls, relays, etc.).

Note: The term "point" is used extensively throughout this manual. It is a generic term used to refer to an individual component of the system, such as a single smoke detector, a single break-glass manual call point, etc.




Figure 1-2. Operator Interface

The InfoAlarm operator interface, shown in Figure 1-2 and described in Table 1-1, allows a system operator to control and monitor the site-specific components connected to the 4100ES.

**Important Note**: The degree to which you are allowed to control the system depends on the passcode assigned to you. See Chapter 7 for details on this.

Standard Fire Fighter operations do not require a passcode.

### **Control Keys & Indicators**

#### Overview


Figure 1-3. Control Keys and Indicators

The control keys and indicator LEDs are located on the far left of the operator interface as shown in Figure 1-3. Each control key is pressed to perform the labelled function, and the associated LED turns on to show the function is active. Pressing the key again de-selects the function and turns off the LED.

# Control Keys & Indicator Functions

- **ZONE ALARM** The red indicator is on when there is an active alarm in any zone.
- FAULT TEST ON This indicator lights when zone fault tests have been enabled by pressing the ALARM/FAULT TEST key. When this indicator is on, and a zone isolate key is pressed, a fault test is performed on that zone.
- ALARM TEST ON This indicator lights
  when zone alarm tests have been enabled by
  pressing the ALARM/FAULT TEST key.
  When this indicator is on, and a zone isolate
  key is pressed, an alarm test is performed on
  that zone. Any programmed outputs will
  operate (including the Brigade signal). If the
  zone was already isolated then the test will
  not de-isolate it, i.e., the programmed
  outputs will not operate.

CAUTION: OPERATION OF THE ALARM/FAULT TEST KEY MAY CAUSE ALARM SIGNALS TO SOUND OR FAULT CONDITIONS IN THE SYSTEM.

 ALARM/FAULT TEST – This key cycles between Alarm Test, Fault Test, and Normal for zone test modes.

The following keys can be pressed at any time. The key feedback (beep on buzzer) and the LED turning on/off may be the only acknowledgment of the action.

- A/C AUTO/RESET The indicator lights when the air conditioning system is automatically controlled by the 4100ES.
   Pressing the key after all alarms have been cleared will reset the air conditioning system to normal operation.
- **ACF ISOLATE** When this indicator is on the ancillary controls: door holders, security trips, etc., are prevented from operating.
- **EXT BELL ISOLATE** When this indicator is on the fire alarm bell or strobe lamp is prevented from operating.
- WARN SYS ISOLATE When this indicator is on the Warning System is prevented from operating.
- LAMP TEST pressing this tests all the indicators on the front of the 4100ES panel.

# **Normal Appearance of Operator Interface**

#### **Description**

The 4100ES operator interface panel shows the following under normal conditions:

- Green AC Power LED is ON, indicating the panel is receiving AC Power.
- All other LEDs are off.
- The alphanumeric display reports that the system is normal and shows the current time and date, as shown below:



Note: If the appearance of the operator interface is not as shown above, refer to the information in Chapters 2 and 3 for instructions on managing the alarm, fault, or isolate condition.

# **Chapter 2 Managing Alarm Conditions**

#### Introduction

An *alarm condition* occurs when an actuating device (such as a manual call point, smoke detector, etc.) activates. The 4100ES indicates the presence of the alarm condition through messages it displays on the alphanumeric display, by illuminating the ALARM indicator LEDs, and by activating the building's EWS and external bell.

This chapter describes using the operator interface keys to investigate and manage alarm conditions.

### **Acknowledging Alarms**

What the System Does When an Alarm Occurs

When the first alarm condition is detected by the 4100ES, the panel does the following to indicate the presence of the alarm:

- Red Fire Alarm and common Zone Alarm LED indicators flash.
- Red Zone Alarm LED flashes on the display module to show the affected zone.
- Sounder (buzzer) pulses.
- Emergency Warning System (EWS) and External bell activate.




Figure 2-1. Alphanumeric Display Showing Example Alarm

- Alphanumeric display on the operator interface shows the location and type (smoke, call point, etc.) of the first point in the alarm condition, and also the most recent alarm, if there are several. An example display is shown in Figure 2-1.
- Any programmed outputs, including the Brigade connection, operate.

Overview – Acknowledging Alarms

The first step in managing an alarm condition is to *acknowledge* the alarm. Acknowledging an alarm does two important things:

- It records the time and date at which you observed the presence of the alarm and stores that information in the system's historical log.
- If multiple alarms are present, the system displays specific data for the next alarm when you press the <FIRE ALARM ACK> key.

## **Acknowledging Alarms, Continued**

#### **Procedure**

Use the following procedure to acknowledge alarm(s):

- 1. Unlock and open the enclosure door.
- 2. Press the <FIRE ALARM ACK> key. Pressing the ACK key causes the following to
  - Buzzer silences.
  - Fire Alarm indicator changes from flashing to steady ON.
  - Alarm acknowledgement message on the graphic display.



3. After the new alarm is acknowledged, the list of all current alarms is displayed, with the first alarm at the top of the list.



Use the <Up>, <Down>, <Page Up> or <Page Dn> keys to move the highlight to the event of interest to select it for more information.

The <More Info> soft key will display more information about the selected device in alarm. The <Event Time> soft key will display the time that the highlighted event occurred.

### Isolating (Silencing) the Warning System or External Bell

#### Overview

When an alarm condition occurs, the building's warning system activates to warn the building's occupants about the alarm condition. In addition, the external bell sounds to indicate the location of the 4100ES to the fire brigade. During maintenance or testing, these outputs can be prevented from activating by isolating them before an alarm occurs. In a real alarm situation, they should be left operating until brigade personnel choose to turn them off.

#### Isolating the EWS

While the alarm exists and the zone is not isolated, pressing the <WARN SYS ISOLATE> key (control key) toggles the state of the warning system output.

The following occurs when the <WARN SYS ISOLATE> key is first pressed:

- Warning System Isolate indicator turns steady ON.
- The Emergency Warning System (EWS) turns OFF. If the EWS is a separate system (e.g. EWIS), then you may have to manually reset the EWIS panel.

If another alarm occurs, the 4100ES will not activate the EWS again until the warning system is de-isolated. Do this by pressing the <WARN SYS ISOLATE> key again so that the Warning System Isolate indicator turns OFF.

When the alarms in the panel have been reset, leave the EWS de-isolated.

# Isolating the External Bell

While the alarm exists and the zone is not isolated, pressing the <EXT BELL ISOLATE> key toggles the state of the external bell output.

When the bell is sounding due to an alarm condition, pressing the <EXT BELL ISOLATE> key once does the following:

- EXT BELL ISOLATE indicator turns steady ON.
- The External Bell turns OFF.

If another alarm occurs, the 4100ES will not activate the external bell again until it is deisolated. Do this by pressing the <EXT BELL ISOLATE> key again so that the EXT BELL ISOLATE indicator turns OFF

When the alarms in the panel have been reset, leave the external bell de-isolated.

#### Isolating the Zone

Note that pressing the Isolate key for every zone that is in alarm will turn on each corresponding zone isolate LED and turn off all outputs activated by the zone being in alarm, such as the warning system and external bell.

Note also that with a point or zone in alarm, e.g., from an Alarm Test, these Isolate keys can be used during testing to briefly allow an output to turn on and check that it works.

## **Isolating ACF Outputs**

#### Overview

The Ancillary Control Facility (ACF) consists of relay outputs which can be used to control equipment which is not part of the 4100ES fire alarm system, such as shutting down air conditioning or returning lifts to a certain floor.

During maintenance or testing, these outputs can be isolated, to prevent unwanted annoyance to the building occupants.

#### Operation

Press the <ACF ISOLATE> key once. The <ACF ISOLATE> indicator will light, and the Isolate indicator above the <Isolate Ack> key will flash. The LCD will display a message:

# ACF ISOLATE PRESS <ACK> key to acknowledge

Press the <Isolate Ack> key to acknowledge that the ACF is isolated.

Note that isolation takes effect immediately from pressing the <ACF ISOLATE> key, not from when the <Isolate Ack> key is pressed.

#### Restoration

Press the <ACF ISOLATE> key once. The ACF ISOLATE indicator goes out.

Note: If there are any alarm conditions still active, the ACF outputs will operate as programmed, e.g., shut down equipment.

### **Resetting Alarms**

#### Overview

The Alarm state and some Fault conditions latch within the panel so they can be acknowledged and viewed. When the latched states are no longer required they can be reset.

The condition that caused each point to go into alarm must be cleared before the system can reset to the normal state, e.g., smoke cleared from smoke detectors, glass replaced in manual call point.


#### Reset Procedure

Press the <SYSTEM RESET> key. What happens next depends on whether all alarm conditions are clear or not, as follows:

• If any Alarm Condition is Not Clear, the system attempts to reset the points in alarm for 25 seconds. During this interval, it displays a message that reads, "System Reset in Progress".



When the reset is successful and complete, this message is displayed:



If any point alarm fails to clear, e.g., smoke is still present, the system displays a message that reads "Alarms Present – System Reset Aborted".

Note: If an alarm cannot be cleared, you must clear (fix) the condition that is causing the alarm or disable the point from the panel. Refer to "Disabling a Point" in Chapter 4 for information on doing this.

• If all Alarm Conditions are Clear, the system does a hardware reset, which generally takes almost no time.

## **Resetting Air Conditioning Controls**

#### Overview

The 4100ES may be used to control building air conditioning systems during a fire alarm.

During the management of the alarm, it is often desirable to be able to delay restoring the air conditioning system to normal operation, e.g., to clear smoke even after the alarm conditions have been cleared.

The A/C RESET control allows this delayed restoration.

#### Indication

When a zone alarm occurs, among the other alarm indications, the A/C AUTO indicator lights to show that the 4100ES has taken control of the air conditioning system. This operation remains in effect even after all alarms have been cleared and the 4100ES system has been reset and is back to normal.

#### Resetting

Before the A/C AUTO operation can be reset, all alarms must be acknowledged, and the alarms must be reset to normal via the <SYSTEM RESET> key.

Once the system reset is complete, and there are no alarms present, the <A/C AUTO RESET> key can be pressed to restore the air conditioning system to normal operation. The A/C AUTO indicator will turn OFF.

# **Displaying Event Time**

#### **Procedure**

When viewing the lists of Alarms or Faults or Isolates, the time of any event can be shown by highlighting the event and pressing the Event Time soft key.

Press <Fire Alarm Ack>, or <Isolate Ack> or <Fault Ack> to display the desired list. Use <Previous>, <Next>, <Page Up> or <Page Dn> keys to scroll the highlight to the event of interest, and press the <Event Time> soft key.



The time and date that the event happened will be displayed.

# Chapter 3 Managing Fault and Isolate Conditions

#### Introduction

Fault conditions are used to indicate something wrong, e.g., the presence of a field wiring problem (circuit break, short or ground), somewhere between the 4100ES and one of its points. Faults are also used to indicate a problem with the option cards, power supplies, network card, etc., in the 4100ES.

Note that disabling a point introduces a fault condition into the system.

Isolate conditions exist when one or more zones have been manually isolated by an operator, e.g., to prevent a false alarm when maintenance work (building repairs, welding, etc.) is being done in an area.

This chapter describes using the operator interface keys to investigate the details of the fault condition, and to view isolate conditions.

## **Acknowledging Fault or Isolate Conditions**

How the 4100ES Indicates the Presence of a Fault or Isolate condition When a Fault or Isolate condition is present in the 4100ES, the operator interface does the following:

- The yellow "FAULT" or "ISOLATE" indicators flash.
- The sounder (buzzer) sounds steady.
- The display on the interface panel indicates the first Fault or Isolate condition, as shown below, and the most recent condition as well, if there are several:



Figure 3-1. Operator Interface Showing Fault Condition

# What Acknowledge Does

The first step in managing a fault or isolate condition is to *acknowledge* the condition. Acknowledging a fault or isolate condition does two important things:

- It records the time and date at which you observed the presence of the condition and stores that information in the system's historical log.
- When you press the <FAULT ACK> or <ISOLATE ACK> key, the system displays
  specific data on the location of the condition. (In the case of Isolate it gives confirmation
  on the LCD that you have isolated the correct zone).

# **Acknowledging Fault or Isolate Conditions, Continued**

#### Panel Operating Procedure – Fault Condition

- 1. Unlock and open the panel door. The yellow Fault or Isolate indicator (LED) will be flashing and the sounder (buzzer) sounding.
- 2. Press the <FAULT ACK> or <ISOLATE ACK> key as appropriate. An acknowledgement message is displayed (this example for Isolate):




Figure 3-2. Operator Interface Showing Isolate Acknowledgement

After the acknowledgement, the list of Faults or Isolates is displayed, with the earliest Fault or Isolate at the top of the list.

# Resetting Fault Conditions

Most faults *automatically clear* from the system when the problem causing the fault (wiring, device, etc.) has been fixed.

Some faults, such as open circuit faults on IDNet communications lines, latch until they are reset manually or cleared by pressing the <SYSTEM RESET> key once the fault condition has been fixed.

# **Viewing Fault or Isolate Conditions**

#### Overview

You can view the list of acknowledged Fault or Isolate conditions at any time:

Press the <FAULT ACK> or <ISOLATE ACK> key to display the Fault or Isolate list. The first Fault or Isolate condition in the list appears at the top of the display.




Figure 3-3. Isolate List after Acknowledgement

- 2. You can use the <NEXT> or <PREVIOUS> keys to scroll the highlight through the list, or <PAGE DN> or <PAGE UP> keys to take larger steps.
- 3. While viewing the list, pressing the <More Info> soft key will display more information about the highlighted device that has the fault or the isolate condition.

After 60 seconds, the system will revert to displaying the first and last Fault conditions, or first and last Isolate condition if there no faults.

# Chapter 4 Selecting Points for Status or Control

#### Introduction

Many of the operations that can be accomplished from the operator interface first require you to select the point on which you want to perform the operation. Points can be selected in one of two ways:

- From the Alarm, Fault, or Isolate List. Points that are reporting an alarm, fault or isolate condition can be selected from the alarm, fault or isolate list by pressing the <ALARM ACK>, <FAULT ACK> or <ISOLATE ACK> keys as appropriate, to display the corresponding list, and then scrolling to the particular point.
- Using the Function/Numeric keys to directly select the point.

### Selecting Points with the Function/Numeric Keypad

#### Overview

The Function/Numeric Keypad, shown in Figure 4-1 below, allows you to quickly select points. For example, pressing the **AUX** key (key also labelled 3) selects the auxiliary relay point category. After selecting a category, the points of that type are displayed on the screen. You can type the number of the desired point directly, or scroll through the list to find it.

After a point has been displayed, you can scroll through all the points in the system from that point, or select another point directly by entering another identifier using the keypad.

You can select either a local point or a network point. A local point is one that is physically connected to the panel in front of you, and a network point is one that is located on a different panel but has been programmed so that it can be selected and controlled from the panel you are at.

There may be several ways of selecting a point. Generally, the most convenient way is to use the point name, e.g., AUX 3 for a relay or M2-3 for an IDNet device.

Some system points can be selected only by their direct address, but there is not normally any need to work with these points. The point name method is recommended.

The format for entering a point name requires a hyphen between levels. For example, a module with address 12 on IDNet loop 4 may have two sub-points. The address of sub-point 2 on that device is IDNet 4-12-2.

Only numbers and the hyphen keys are valid entries. The maximum number of digits allowed in an identifier input is eleven (11), including the hyphens, excluding the <ENTER> key. See Table 4-1 for other examples.

# Selecting Points directly

Refer to Table 4-1 for information on using the Function/Numeric keypad to select points on this panel.




Figure 4-2. List of matching points having selected "IDNet" point type

Enter the IDNet channel number, a dash, and the device address ("1-20" in this example). The displays scrolls as the address is entered, to the show first matching point.




Figure 4-3. Nearest matching point as the point name is being entered

- 1. Use the <Up>, <Dn>, <Page Up> or <Page Dn> keys on the keypad to scroll the highlight to the exact point you want.
- 2. Press the <Select Item> soft key to select it.

# Chapter 5 Testing and Controlling Points

#### Introduction

This chapter describes using the panel's action keys (ALARM TEST, On, Off, etc.) to test and control zones and points.

#### **Alarm and Fault Test for Zones**

#### **Alarm Test**

Alarm Test forces a zone into the alarm state. Once the zone is in alarm, you can check to see if the system reacts in the way that it has been programmed, i.e., do signals sound in the correct manner? do relays function correctly? etc.

Note: When you force a zone into alarm, if the zone is not isolated, then any outputs that are programmed to activate on alarm will activate: Brigade signalling, Warning System, etc.

Follow these steps to perform an alarm test on a zone:

1. Press the <ALARM/FAULT TEST> key. The ALARM TEST LED will turn on.



Figure 5-1. Ready for Zone Alarm Test

2. While the ALARM TEST LED is on, press the appropriate Zone Isolate key (see the next section). This zone will go into alarm: the corresponding red Zone Alarm LED will turn on, along with the Fire Alarm display on the main screen.

#### **Fault Test**

The fault test allows you to simulate a fault condition on a zone. This allows you to test the manner in which the FIP reacts to the fault, e.g., verify the operation of the brigade interface.

Note: When you force a zone into fault if the zone is not isolated then any outputs that are programmed to activate on fault will activate, including Brigade signalling.

Follow these steps to perform a fault test on a zone:

1. Press the <ALARM/FAULT TEST> key until "FAULT TEST READY" is displayed. The FAULT TEST LED will turn on.



Figure 5-2. Ready for Zone Fault Test

2. While the FAULT TEST LED is on, press the appropriate Zone Isolate key on the zone display panel (see the next section).

Note: The Alarm or Fault Test function will be cancelled if the Alarm/Fault Test key is pressed again, or after 1 minute of no testing.

## **Isolating and De-isolating Zones**

#### Overview

This section describes isolating and de-isolating zones. Isolating a zone does not prevent any of the points within the zone from going into the alarm state, but does prevent the activation of any outputs that are programmed to operate when the zone is in alarm.

Pressing a zone's ISOLATE key toggles its Isolate status. If the zone is not isolated, pressing the key isolates the zone. Likewise, if the zone is isolated, pressing the key de-isolates the zone.

Note: If the ALARM TEST LED or the FAULT TEST LED is on, then pressing the ZONE ISOLATE key will not isolate/de-isolate the zone, but activate the alarm or fault test.

#### Isolating a Zone

A zone is isolated by pressing the appropriate Isolate key on the Zone Display Module. Zone Displays are located below the operator interface. Each Zone Display Module has eight zones:




Figure 5-3. Zone Isolate controls and Indicators

- 1. Press the Zone Isolate key so that the Zone Isolate LED turns on.
- 2. Press the <ISOLATE ACK> key to acknowledge the isolate operation.

#### De-Isolating a Zone

Zones are de-isolated by pressing the appropriate Zone Isolate key on the Zone Display Module:

1. Press the ISOLATE key so that the Zone Isolate LED turns off. Acknowledgement is not required.

**Warning**: If the zone's Alarm LED is on, do not de-isolate the zone unless you are sure that you want to create an alarm.

## **Disabling and Enabling Points**

#### Overview

Situations such as a malfunctioning detector causing false alarms, or an activated detector that prevents the system from being reset, can be temporarily overcome by disabling that particular point.

Disabling a point allows the system to be reset while repairs are being made. It takes the point "offline". Disabling a point prevents the point from entering an Alarm or Fault condition while it is disabled.

# Disabling a Point

To disable a point:

- 1. If necessary, log in at a suitable service level (see Chapter 7).
- 2. Select the point that you want to disable. Refer to Chapter 4 for information on selecting points.




Figure 5-4. Selecting a point to disable

2. Press the <DISABLE> soft key. The point is disabled immediately.



Figure 5-5. Point Disabled confirmation message

The system generates a Fault condition and message, indicating that the point is disabled.

**Note:** To disable a point that is in Alarm or Fault, press the <Fire Alarm Ack> or <Fault Ack> as appropriate key to display the Alarm or Fault list, scroll to the desired point, then press the <More Info> soft key and then the <DISABLE> soft key.

# Enabling a Point

To enable a point:

- 1. Select the disabled point that you want to enable, e.g., by selecting the point directly, or by scrolling through the Fault list to find it.
- 2. Press the <ENABLE> soft key.




Figure 5-6. Count down message during enabling a point

**Note:** The system displays a message indicating that the point will be enabled in 60 seconds, and counts down. If the state of the device is such that an alarm condition will occur when the point is enabled, the system warns you that this will happen. You can abort the enable operation before the countdown timer expires by pressing the <DISABLE> soft key.

You can make the enable happen immediately by pressing the <ENTER> key during the count down.

# **Turning a Point ON or OFF**

#### Overview

It may be necessary during testing and maintenance of the system to force outputs on or off, e.g., alarm devices and relays.

Turning an output point off is effectively isolating that output. Once turned off, the output will not turn on, even if an alarm condition that is programmed to turn it on occurs. After the maintenance it is necessary to return the output to automatic control.

Turning an output point on forces the output to activate, even if there is no condition present that is programmed to turn it on. Some control points, e.g., Sonalert (buzzer) Inhibit, see below are normally off, and may be turned on to perform a function. These must later be restored to "off", not "auto".

# Turning a Point ON

1. Select the output point that you want to turn on. Refer to Chapter 4 for information on selecting points.




Figure 5-7. Selecting a point to turn on or off

2. Press the <Select Item> soft key. This will show detailed information about the selected point, plus appropriate soft keys to control that point.





Figure 5-8. Available soft key actions for a selected point

3. Press the <ON> soft key. A confirmation message will be displayed:



Turning an output point on or off generates a "Manual Override Fault," which is used to remind you that a point has been forced into the On or Off state. You have to acknowledge the fault by pressing the <FAULT ACK> key.

# Turning a Point OFF

- 1. Select the output point as described in the previous section.
- 2. Press the <OFF> soft key.

Turning an output point on or off generates a "Manual Override Fault," which is used to remind you that a point has been forced into the On or Off state. You have to acknowledge the fault by pressing the <FAULT ACK> key.

### Returning a Point to Automatic Operation

When you are ready to return the point to automatic operation , i.e., the system, not the operator, controls the point, you need to select the point as described above, then press the <AUTO> soft key.

Note: this action will not directly update the point's status to the automatic value. The point status will change only when the system decides that an update is required. To force this update, do a warm restart of the system (see Chapter 9).

### Sounder (Buzzer)

A loud buzzer is used in the Australian 4100ES to meet the requirements of AS 4428 (70dB at 1m with the door closed).

If doing testing or maintenance on the system with an operator at the panel, the buzzer may be inhibited by turning point P198 on.

Note that the point must be turned off when the panel is to have its door closed.

# Chapter 6 Displaying and Modifying Detailed Point Attributes

### **Detailed Point Attributes**

**See the Attributes** When the point is selected, the display shows a list of the point's attributes. Different types of

points will show a different list of attributes.

Summary of Display-Only Attributes Table 6-1 summarizes the attributes displayed for a selected point.

## **Detailed Point Attributes, Continued**






The 4100ES uses four access levels, referred to by the numbers 1 through 4, to control what operators can do with the system. The system typically operates at access level 1, which allows an operator to accomplish basic tasks without logging in to the system.

Other functions, for example certain control functions, may be passcode protected to prevent access by unauthorized personnel.


### Log In Procedure

Follow these steps to log in to the system at access level 2, 3, or 4:


- 1. Obtain the passcode for the access level at which you want to operate.
- 2. Press the <MENU> key. Highlight the Access option, and press <ENTER> or <Select Item>.



3. Select Login option, and press <ENTER> or <Select Item>.



4. Enter the passcode for the access level. The passcode can be up to 10 digits in length. Press the <ENTER> key on the numeric keypad when you have finished entering the code. A \* is displayed for each digit of your passcode, as shown here:


5. If the passcode entered in Step 4 is correct, the following message is shown:



### **Log Out Procedure**

Failure to log out may allow unauthorized personnel access to the various protected functions. If no keypad activity is detected for ten minutes, the system automatically returns to Level 1 access.

 Press the <MENU> key. Highlight the Access option and press <ENTER> or <SELECT ITEM>.



2. Highlight the Logout option and press <ENTER> or <Select Item> key. The following message is displayed:



**Note:** Logging in at access level 4 creates a fault that requires a Warm Restart of the system to clear (see Chapter 9). This ensures that the system is returned to its normal operating mode following service.

# Chapter 8 Viewing and Clearing Historical Logs

### Introduction

When an abnormal condition occurs, a record of the event is placed in one of two logs generated by the system, depending on the nature of the condition. These logs are:

- Historical Alarm Log
- Historical Fault Log.

The historical logs contain a time stamp of the events generated by abnormal conditions in the system. The information displayed with these logs is historical data only and will not contain any current point status. Separate lists are maintained for alarms and for isolates/faults. This chapter describes displaying and clearing these historical logs.




### **Viewing Logs**

The Historical Alarm and Fault Logs can be viewed from the 4100ES operator interface:

1. Press the <MENU> key. Move the highlight to the Logs option, and press <ENTER> or <Select Item>.




2. Move the highlight to the type of log you wish to see. Press <ENTER> or <Select Item>.


Every card, including the Master Controller and all option cards, has a series of Card Status Points associated with it. For the SPS (System Power Supply) these points include System Voltage, System Current, and Battery Voltage.

- Press the <MENU> key and navigate to the Panel Info Menu as described in the previous section.
- 2. Scroll the menu highlight to "Show Card Status" and press <Select Item> softkey or <ENTER> to show the Select Card menu:



3. Use the Previous, Next, Page Up, Page Dn keys to scroll to the desired card. Press <Select Item> softkey to show the Card Status for this card.




### Viewing Card Status Information, Continued

Power Supply/Charger Voltage and Current Readings

Some cards require several screens to display all the status information. This is particularly the case for the SPS, where the second screen shows the system and battery voltages and currents.


### **Displaying Network Node Information**

### Overview


Networked systems consist of multiple panels linked via a 4120 network. Each panel has a programmer-defined node number, used to identify the panel on the network. The following section describes how to determine a panel's node number. The node number is required when selecting a network point. See "Selecting Points" in Chapter 4 for more information on doing this.

### **Procedure**

1. Press the MENU key to display the Main Menu. Scroll the highlight to "Panel info: Stat and Revisions?", and press <Select Item> soft key or <ENTER>.




2. In the Panel Menu, scroll the highlight to "Network Status and info", and press <Select Item> soft key or <ENTER>.




### **Displaying Network Node Information, Continued**

3. In the Network Info Menu, there are three options:




Highlight the desired option and press <Select Item> soft key or <ENTER>.

NodeID – show the node name of this panel.



• Node Status – shows the network configuration version and the on-line status of all nodes in the network.



• Network Topology – shows the order of all the nodes in the network, from "left" to "right" starting with the master node. The node number for the local panel will be displayed in parentheses.



### **Lamp Test**

### **Procedure**

The "LAMP TEST" push-button on the operator interface is used for identifying local lamp (LED) failures within the system. LEDs on the 4100ES operator interface and Switch/LED Display Modules illuminate.

Perform the following procedure to check correct LED or LCD operation:

- 1. Press the "LAMP TEST" push-button. All LEDs should illuminate (LEDs should stay illuminated for as long as the push-button is depressed). Holding the push-button in for more than 3 seconds will test the buzzer.
- 2. Perform an individual lamp test on all remote LCD annunciators using the key switch on the remote annunciator.
- 3. If you find defective lamps/LEDs, contact your local Simplex agent.

### Warm Restart of the System


#### Overview

A Warm Restart is used to reset some higher level operations of the 4100ES, such resetting system points to their default values, and clearing service-related fault conditions.


The Warm Restart function is not required for normal operation of the 4100ES panel, and the option to restart is visible and available only if you are logged in at an appropriate access level (see Chapter 7).

### **Procedure**

1. Press the MENU key to display the Main Menu. Scroll the highlight to "Service / Diagnostics?", and press <Select Item> soft key or <ENTER>.



2. In the Diagnostics Menu, scroll the highlight to "Restart Panel?", and press <Select Item> soft key or <ENTER>.



In the Reset Menu, highlight the "Warm Restart" option, and press <Select Item> soft key or <ENTER>.

Press <OK> or <ENTER> to confirm the panel restart.

The panel will be off-line briefly during the restart.

### **Displaying IDNet & Mapnet Device Status**

#### Introduction

The IDNet options allow the use of addressable devices and TrueAlarm sensors with the 4100ES FIP. Addressable devices communicate the exact location of an alarm to the system operator interface panel, improving recognition of the condition and subsequent response. It also pinpoints the precise location of fault conditions via the device custom label. Throughout this section, operations described for IDNet are also applicable for Mapnet.

# IDNet Display Information

When an IDNet device changes to an abnormal condition, or the operator enters an IDNet device address, the LCD display shows the current status of the IDNet device. After entering an IDNet device address, press the <MORE> soft key on the operator interface panel to display additional device information.

### IDNet Point Addressing

Each IDNet device must have a point address in order to communicate with the 4100ES FIP. These point addresses along with their custom labels are located in the Programmers Report. The Programmers Report shows the address for each device, separated by hyphens. Hyphens must be used when entering an IDNet address into the system. An example of an IDNet device address is "M1-5". The "M1" portion of the address identifies the IDNet loop or channel, loop 1 or channel 1. The "5" portion of the address, identifies the device number, number 5.

Note: Multipoint IDNet devices use *sub-point addressing*. These sub-points are addressed as C-DD-S, where S is the sub-point. Example: A FRIAM device has a relay at sub-point 1 and an input at sub-point 2 which would be accessed as M1-5-1 and M1-5-2 respectively.

# How to Display an IDNet System Point

See Chapter 4, "Selecting Points for Status or Control" for IDNet operations.

# What To Do If an IDNet Point Will Not Reset

If an IDNet device will not reset, you may decide to disable the point. When the disable procedure is performed, a System Fault occurs to remind you that the point is disabled. The disable procedure is the same for all system points (see Section 5, "Disabling and Enabling Points"). Maintenance personnel must be called immediately to repair the malfunction.

After the IDNet point is repaired, you can enable the point again.


### TrueAlarm Sensor Display Values

Using the 4100ES InfoAlarm display and the display/action keys, the control panel can display various status conditions for each TrueAlarm sensor, including the sensor's present selected sensitivity level as a percent of obscuration per foot (% OBS/ft). This selected sensitivity level is the value at which the FIP will cause an alarm condition. Seven sensitivity levels are available for the TrueAlarm photo-electric sensor. The most sensitive setting is 0.2% OBS/FT (0.5% OBS/m) with the least sensitive setting being 3.7% OBS/FT (12% OBS/m).




The point name is called up, using the procedure described in Chapter 4. Currently, the subpoint 0 is highlighted in the list of points.



Press <Select Item> softkey or <ENTER> for the 0 subpoint to show the basic information about this point.



Going back to the Direct Point Call-up display, and scrolling the highlight to subpoint 1 (the photoelectric sensor), and selecting this point will show the detail for subpoint 1 (the detection element in this example):

The Average Value is the average of the last 2048 samples received from the sensor. The Alarm Level is the binary value that is used to determine alarm conditions. This value will change over time as the panel compensates for environmental conditions. The alarm value will be different for each of the seven sensitivity levels.

The Value is the most recent value received from the sensor. It is shown as the binary value, as % of alarm level (max 100%), and as a smoke level in %/ft.

The Peak is displayed as a binary value, a % of alarm and a % smoke obscuration per foot. Through the use of a system pseudo point all new peak values per sensor can be stored in the history fault log and printed on the optional 4100ES system printer. Printing of peak values is done at the time the peak value is received at the FIP. This peak value is helpful in determining if a sensor should be made more or less sensitive.

# Chapter 10 Walk Test Procedures

### Introduction

The following test features can be used when commissioning after the system is installed, and during periodic testing as required by code. Refer to Chapter 12, Maintenance Procedures for detail on these.

### Walk Test™

#### Overview

WalkTest allows the function of the system's initiating devices to be tested by a single person.

Detection devices (with the exception of manual call points) automatically acknowledge and automatically reset, allowing for one-man testing without the need for someone at the main control panel to acknowledge and reset the system each time an initiating device is activated.

4100ES has the ability to briefly activate sounders to confirm detection device operation. However, the tone generators or EWIS used as the warning system in Australian installations will not reliably work with these brief activations.

In general, a silent WalkTest should be used (no signals will sound) and logging of events should be selected. If an alarm condition is detected from a zone that is not in any presently active Walk Test group, the system will operate as a fire alarm panel and the active Walk Test groups are aborted.

Conducting a WalkTest requires you to perform the following steps.

- 1. Enable WalkTest Options from the Front Panel. These options include the following:
  - Which WalkTest Group is enabled.
  - Whether the group's warning signals turn on when a control point in the same group activates. Normally, this should be set to Silent.
  - Whether logging of Walk Test events is enabled or not. Normally, this should be set to On, to get time stamped event messages.
  - Refer to the "Setting WalkTest Options" later in this section for information on setting these options.
- 2. Manually activate the detection devices in each group and interpret the indicators. Activation can be done using a magnet or canned smoke.

Make sure to proceed in a logical manner, i.e., start with the lowest IDNet or MAPNET address and work toward the highest.

When testing the devices, use the alarm LED on the smoke detector, or a simple delay, to know when to continue to the next device. After test completion, check the Alarm log (see Chapter 11) to verify that all zones activated the correct number of times and in the correct order.

When you enable the Walk  $Test^{TM}$  mode, a system fault will be reported to remind you that the Walk  $Test^{TM}$  is enabled.

Whenever a Walk Test<sup>TM</sup> group is aborted, manually or automatically, the panel will sound the abort signal (three sets of two short pulses) to indicate that group is going back into service. If a control point in the list is already active (because of an abnormal condition), it is not used to signal the abort.

The group is placed into normal operation 60 seconds after the abort signal is heard. This delay protects against an unwanted alarm should an automatic abort occur while a device is being tested.

The system is default-programmed to allow the Walk Test<sup>TM</sup> to be performed without sounding audible signals. The Walk Test<sup>TM</sup> will not activate any point which is disabled. Therefore, you have the ability to manually exclude any point from the test. (See How to Disable a Point, Chapter 5)


You may enable the logging of Walk Test<sup>TM</sup> events, which allows each zone with an abnormal condition to be time tagged and added to the fault log. This is beneficial when a 100% silent Walk Test<sup>TM</sup>, without visuals, is required.

### **Zone Coding Option**

The system supports two types of audible signalling to indicate an alarm condition on a zone. By default, "zone coding" is used. This code matches the "ZONE" number associated with that point. The zone code is only used the first time a zone is reported. For subsequent alarms on the same zone, a single "0 CODE" (two short pulses) is used.

Zone coding is normally used with TrueAlert notification appliances which are not used in Australian installations. The information is included here for reference.

Examples of Zone Coding are shown below.



**NOTE:** Zero Code = 2 short pulses.

Zone coding may be individually turned On or Off for each of the eight Walk Test<sup>TM</sup> groups, Group 0 through Group 7, using the interface panel's display. When zone coding is Off, a "0" code is always used, even for the first alarm. This method of testing is more appropriate for maintenance testing, once all wiring is verified.

When a control point is pulsed by Walk Test<sup>TM</sup>, it is done without affecting the priority of that point regardless of its present value. This guarantees that Walk Test<sup>TM</sup> does not interfere with any required SMPL (software) operations during a real alarm.

IDNet monitor devices sound the zone code, with the first digit being the channel number, followed by the device's address number. Example: M1-1 sounds a "1,1" code. M4-123 sounds a "4, 1, 2, 3" code. IDNet signal devices cannot annunciate codes.

### Silent Walk Test

The control points to be activated (pulsed) during Walk Test<sup>TM</sup> are determined by the contents of the control lists which are configured when programmed. Several options are available when configuring a silent Walk Test<sup>TM</sup> control list. The first option is to NOT put any audible signals into the control list. The second option is to disable individual audible control points from the front panel, one at a time. The last option is to select Silent signalling from the Walk Test<sup>TM</sup> menu. If this last option is selected, none of the points in the control list will sound.

Walk Test<sup>TM</sup> is enabled through the interface panel's alphanumeric display, as described in the next section.


Note that Walk Test<sup>TM</sup> is passcode protected. The Walk Test<sup>TM</sup> option will not appear in a menu unless the operator has logged in at the proper access level (see Chapter 7).

When the 4100ES system is placed in Walk Test<sup>TM</sup> mode, any zone in the active Walk Test<sup>TM</sup> group(s) can be tested in any order. If zone coding is enabled, there is an advantage in testing all devices within one zone before going on to the next zone.


You should simulate an alarm and fault condition for each device being tested. If you are using an audible or visual indication, wait for it to clear before you test the next device. Otherwise, wait for an appropriate amount of time (based on the system reset delay) before moving on to the next device. The LED on a smoke detector helps you in this area because it indicates when the alarm is sensed, and when the detector resets. If zone coding is enabled, verify that the code heard or seen is correct.

### Walk Test™Procedures

How to Enter Walk Test Mode Log into the 4100ES panel at the necessary access level (Level 2 or higher). In the main menu screen on the InfoAlarm, scroll the highlight to the Service/Diagnostics option and press the <Select Item> softkey or <ENTER>:




In the Diagnostics Menu, scroll the highlight to the Walktest option and press the <Select Item> soft key or <ENTER>:



### Walk Test™Procedures, Continued

How to Enter Walk Test Mode The Walk Test<sup>TM</sup> Settings menu allows the settings for each group to be individually adjusted. Use the <Next Group> or <Prev Group> soft keys to step through the Walk Test groups 0 to 7. The list rolls around in either stepping direction.


For each Walk Test group the current settings are displayed:



The settings are:

- Status is this Walk Test group On or Off?
- Logging will test alarms in the group be recorded in the system log or not? Generally, the Log option should be selected.
- Coding if the sounders are enabled, will they do Zone coding or just a simple "0 CODE". If the Signalling option is set to Silent, the Coding setting does not matter.
- Signalling will the sounders for this group activate on a test alarm (be Audible) or stay Silent. Generally, the Silent option should be selected.

To change any setting on the currently displayed Walk Test group, use the Up or Down keys to scroll the highlight to the setting to change, and press <Select Item> or <ENTER>.



In the settings display, the highlight shows the current setting. Use Up or Down to move the highlight to the other setting, then <Select Item> soft key to change it.

### Walk Test™Procedures, Continued

### How to Exit Walk Test Mode

When the Walk Test<sup>TM</sup> has been satisfactorily completed, exit from the Walk Test<sup>TM</sup> mode by performing the following procedure:

- Enter the Walktest Settings menu display, as described above.
- Set all the Walk Test groups to Off.
- Log out of the 4100ES system.
- Inform the customer or site management when system testing is completed.

If Walk Test is not specifically turned off as above, the system will automatically abort Walk Test after 90 minutes of inactivity.





It is a requirement of AS 1851 - Maintenance of Fire Protection Systems and Equipment, that regular tests be carried out to ensure the system is fully functional.

Usually a maintenance company carries out the tests under a Service Agreement.

### **WARNING**

It is very important that adequate precautions be taken when doing any testing on the fire alarm system. Outputs of a typical panel include calling the Brigade, activating the building evacuation system, shutting down air conditioning, and may include release of extinguishant within the building.

Brigade signalling must only be tested with prior arrangement and use of the "test key" or other protocol as is applicable to the area.

### AS 1851 Testing – Guide for 4100ES – Specific Test Methods

The 4100ES and its associated equipment must be tested at regular intervals. Test criteria, service intervals, and record keeping requirements are specified in the appropriate Standard, the latest being AS 1851:2012.

The following sections suggest how service persons may perform some of the required inspections and tests, where the method may not be immediately obvious or where special operations for particular features will be required. The references in the tables to "AS 1851 Item Number" refer to Tables 6.4.1.2 through 6.4.1.5 in AS 1851:2012. References to just Section x.y or Chapter z refer to sections in this Operator Manual.

In addition to this, 4100ES automatically performs regular self-tests to help ensure detectors are operational and able to generate alarms, and the battery is connected and has a certain level of capacity.

Note: this is not intended to be used as a complete list of AS 1851 maintenance requirements, nor as a complete test schedule.

### **Battery and Keypad Test Details**

Battery Load Discharge Testing (AS 1851:2012 Item 3.7) The 4100ES Fire Alarm Panel has no provision for load discharge testing of the battery at the levels required for yearly testing to AS 1851:2012.

A load discharge method separate from the panel must be arranged in order to meet this requirement. For example, apply an external test load to the battery and operate the 4100ES with mains power off for 30 minutes. Check the battery voltage at the end of the test.

PSU Supervision (AS 1851:2012 Item 4.5) 4100ES does not include built-in facilities to carry out this test. A suitably rated bench power supply connected to the battery terminals with main power turned off may be used instead.

Ensure the panel is normal -i.e., no faults and no system conditions are present that cause the Fault relay to be operated.

Reduce the bench power supply output voltage to below the minimum operating voltage and check the Fault relay operated.

If the PSU supervision signal is monitored, confirm that it is received at the monitoring service or at the main CIE. The status of the PSU and Battery can be observed in the Card Status recalls (refer Chapter 9). This will indicate Fault condition when the system voltage is below the minimum operating voltage.

Panel Switches and Keypads (AS 1851:2012 Item 3.5)

This involves operating each control on the front panel of the 4100ES. The following sequence will not affect the system, other than leave some entries in the Isolate log. Each key press should produce a chirp from the system buzzer.

Ensure the panel is normal before doing this -i.e., no faults and no system conditions are present that cause the Fault relay to be operated.

### Control Keys:

Alarm/Fault Test – press three times, so that both the Alarm Test On and Fault Test On indicators are off when finished.

ACF Isolate, Ext Bell Isolate, Warn Sys Isolate – press each of these twice, to isolate then de-isolate the output.

Zone Isolate buttons – press each of these twice, so as to leave the zone isolate status unchanged. Key pad – Enter, MENU, C/Exit, then the digit keys in any order.

The Alarm and Warning Ack keys and Silence and Reset keys can be pressed in any order. The soft keys and scrolling keys to the right of the graphic display can be pressed in any order.

Press C/Exit several times when finished to cancel out of any menus.
